MEMORANDUM OF UNDERSTANDING

This Memorandum of Understanding is being entered, on **26th September 2019**

Sadhu Vaswani Institute of Management Studies for Girls having its office at 6, Koregaon Road, Next to St. Mira's College for Girls, Pune, Maharashtra 411001 (herein after, called as "**SVIMS**") which term, shall so far as the context admits be deemed to mean and include its successors and assigns of the **First Part**)

AND

Study Smart Overseas Education, having its corporate office at Office number: 23, 3rd Floor, Gold Field Plaza, opposite Wadia College, 45, Sassoon Road, Pune: 411001. The company has been in business for over 8 years and has proved itself effective in delivering the course of IELTS.

WHEREAS:

1. Study Smart is a premier overseas education consulting firm that offers personalised guidance and counselling to the students who wish to study abroad. While, it also stands as one of the top Coaching centres for IELTS, TOEFL and PTE.
2. SVIMS is willing to enter into a Memorandum of Understanding (MOU) with Study Smart Overseas Education to train their students in IELTS to improve students' job-related skills.

NOW IT IS HEREBY AGREED BY AND BETWEEN THE PARTIES HERETO AS UNDER:

1. Objective:

The objective of this MOU is to **train the students to improve their employment skills** and help them to get a leverage in communication skills in English, as per the job market, (hereinafter referred to as the “Training Programme”) to be conducted at SVIMS premises.

Period of MOU:

This MOU shall come into force and effect from the date of execution and shall remain valid for a period of **3 years** from such date after which, the same may be reviewed by either party. However, if the same is not renewed, this arrangement will be deemed terminated on the expiry of the said duration period.

2. Roles & Responsibilities of SVIMS:

1. Batch Size: A minimum of 20 students
2. The medium of Instruction & Evaluation shall be English
3. Course study material will be provided by Study Smart Overseas Education while the students will also be given access to the online portal of Study Smart Overseas Education which has additional study material
4. Maximum duration of the course will be 6 months
5. The start date of the course will be communicated to Study Smart Overseas Education.
6. Every week, classes will be conducted on _____ and _____ days. Time slot will be from _____ to _____
7. Total course duration of the Training Programme would be of 40 hours
8. Each student would be made available for the course for specified number of hours, per day for the entire duration of the Training Programme
9. The enrolled students will be completing the course as per scheduled duration

10. Attendance will be a joint responsibility of SVIMS and Study Smart Overseas Education. The copy of Attendance will be provided by SVIMS.

11. Attendance record would be kept at SVIMS, with the course in-charge faculty

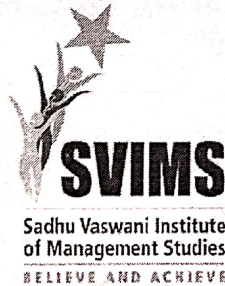

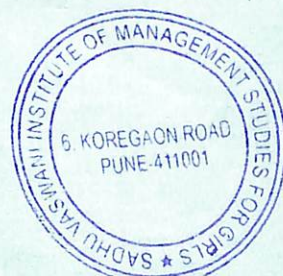

Both Parties may terminate this MOU upon 30 calendar days' notice in writing. In the event of Termination, both parties have to discharge their obligations.



If such an order or other relief cannot be obtained, the party being required to make such a disclosure shall make the disclosure of the Confidential Information only to the extent that is legally required of it and no further.

10. Other Terms & Conditions:

1. Batch Size: For students minimum batch size will be 40. Faculties and admin staff will also attend the session.
2. The medium of Instruction & Evaluation shall be English
3. Course study material will be provided by Disha Computer Institute
4. Maximum duration of the course will be 6 months
5. Course will be started from first week of August and will end on last week of October

6. Every week classes will be conducted on wednesday, Thursday, and Saturday days. Time slot will be from 2 to 5.
7. Total Hours will be 45 Hrs.
8. Each student would be made available for the course for specified number of hours per day for the entire duration of the program.


Therefor the party of the First part and the party of Second part mutually agree to work together to offer, administer and conduct Yoga sessions under below mentioned terms and conditions.


Termination
