

#### **OBJECTIVES:**

- To reduce the Institute's carbon footprint and promote sustainable practices.
- . To minimize energy consumption and encourage energy saving habits.
- To efficiently manage solid, liquid, and e waste through source separation and . recycling.
- . To conserve water resources through rainwater harvesting and responsible water usage.
- To maintain a clean and green campus by preventing waste, promoting ecofriendly . celebrations, and restricting vehicular traffic.
- To eliminate or reduce the use of single use plastic on campus. •
- To actively participate in environmental centric initiatives and awareness programs. .

#### PLAN OF IMPLEMENTATION/PRACTICES

#### A. ENERGY CONSERVATION AND MANAGEMENT:

- Promoting Energy saving Practices: I.
- . Encouraging the use of stairs instead of lifts.
- Replacing ordinary lights with energy efficient LEDs. .
- Designing airy and spacious classrooms with natural light sources. .
- Preventive Maintenance and Efficient Usage: II.
  - Regular preventive maintenance of electrical compliance. .
  - Turning off electricity points when not in use. •
  - Activating power management features on computers, laptops, and printers. •
  - Switching off lights/fans in unused areas. •

#### B. WASTE MANAGEMENT SOLID, LIQUID, AND EWASTE:

- Generation and Source Separation: I.
- Segregating garbage into dry and wet waste. •
- Disposing of sanitary napkins through incinerators. •
- Sending wet waste to Inlaks & Budrani Hospital for biogas conversion. •
- Recycling E-waste through designated agencies
- II. Recovery, Collection, and Recycling:
  - Systematized disposal of E-waste, newspapers, etc. .
- Implementing Brown Leaf for ecofriendly management of dry leaves.





#### III. Wastewater Management:

- Proper treatment, recycling, and utilization of wastewater through an STP plant.
- Using treated wastewater for gardening and road cleaning.

### C) WATER CONSERVATION AND WATER MANAGEMENT:

- Implementing Rainwater Harvesting.
- Installing water flow restrictors and low flow toilets.
- Educating students and employees on water conservation practices.

#### D) CLEAN AND GREEN CAMPUS:

- Avoiding wastage of paper and promoting double-sided printing.
- Using mud/shadu Matti for ecofriendly Ganpati celebrations.
- Restricting the entry of automobiles and encouraging alternative modes of transportation.

#### **E) BAN ON SINGLE USE PLASTIC:**

- Encouraging ecofriendly alternatives for food and beverage containers.
- Restricting the use of single use plastic bottles for inhouse meetings and events.
- Reducing the use of single use plastic banners.
- Segregating nonbiodegradable plastics for safe disposal.

### G) PROMOTION OF VEGETARIANISM FOR REDUCED CARBON FOOTPRINTS

In adherence to our commitment to sustainable practices and environmental responsibility, the consumption of non-vegetarian food is not allowed on campus premises. We recognize the significant impact of dietary choices on carbon footprints. #### Rationale:
