BETWEEN

SVIMS is an ISO 9001:2008 certified and NAAC accredited B-School set up by the Internationally Renowned Sadhu Vaswani Mission, dedicated to the empowerment of a new generation of women managers, who provides both effective and ethical leadership in a resurgent India.

Herein after referred to as “**PCA**” which expression shall mean and include its heirs, successors, executors, administrator, authorized representatives and permitted assigns of the **Second Part**

WHEREAS:

1. PCA is into business of HR Training, GST Training and Digital Marketing Training. Training modules in HR are as follows

Recruitment	End to end recruitment process ,entry to exit formalities
Compensation and benefits	Salary breakup and formations
Statutory compliances	Shop act, PF/ ESI / PT/Gratuity / Bonus acts
Labour laws	Filing of online challans of PF/ESI/PT
Payroll processing	Processing payroll on cloud based software
SHRM	Preparing formats of T&D, PMS, Employee engagement of client requirements

2. SVIMS is willing to enter into a Memorandum of Understanding (MOU) with PCA to train their students under the aforesaid HR training programs /modules in order to improve students job related skills.

NOW IT IS HEREBY AGREED BY AND BETWEEN THE PARTIES HERETO AS UNDER:

1. Objective:

The objective of this MOU is to **train the students** to improve their employment skills and help them to get a better understanding on practical knowledge required in the field of HRM, as per the job market, (hereinafter referred to as the "Training Program") to be conducted at SVIMS premises.

Period of MOU:

This MOU shall come into force and effect from the date of execution and shall remain valid for a period of **3 years** from such date after which the same may be



reviewed by either party. However, if the same is not renewed this arrangement will be deemed terminated on the expiry of the said duration period.

2. Roles & Responsibilities of SVIMS:

- a. SVIMS shall be responsible to nominate one person with adequate accountability and responsibility to coordinate the program. The person so appointed would act as the single point of contact (SPOC) for the proposed Programme.
- b. It would be the responsibility of SVIMS to ensure that proper publicity of the Program is made by encouraging the students by informing them about the benefits of the course.
- c. To make available the infrastructure (including IT infrastructure, applications and connectivity) required for conduct of the program. The infrastructure requirements such as LCD projectors, classrooms, computer labs, PC with internet connectivity, etc., are provided by SVIMS based upon the availability of resources.
- d. To provide all the support services and facilities to PCA during the conduct of the said program.
- e. To coordinate with PCA and facilitate conduct of all the assessments including the assessment to be conducted by the external agency (if any) identified by PCA, as per schedule communicated by PCA.
- f. SVIMS will have the absolute right to dismiss a candidate if the candidate does not align with rules and regulation of the institution, and of the state.

3. Roles & Responsibilities of PCA

- a. PCA shall be responsible to provide the training as per course requirement and curriculum for delivery.
- b. PCA will provide suitable faculties for conducting the course exclusive for classroom training.
- c. PCA will arrange for assessment of its own and also arrange external assessment as required.
- d. PCA will assist candidates in job placements by providing minimum of five opportunities within three months of completion of certificate course to each student for the profile of HR generalist and specialist.



e.PCA will give all required placement support to the Institute including live projects and internships to the HR students.

f.PCA will be responsible for the upgradation and revisions in the course syllabus /content as per market demand.

4. Commercials:

This course carries cost.PCA shall charge the fees which will be mutually decided by both the parties before the commencement of the course every year, and the receipts will be given in the name of the students.

5. Certification:

Certificates shall be awarded by PCA in collaboration with SVIMS to the students on successful completion of the course and clearing of the assessment held post completion of the course.

6. Limitations and Warranties:

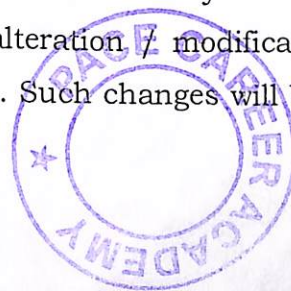
Both parties agree that it would be their endeavour to prevent any liability arising out of default or non-compliance of the MOU terms by either party.

7. Termination:

- a. Both parties can terminate the MOU with a prior written thirty (30) day notice on default of terms or non-adherence to any condition or responsibilities by the other party as outlined in this MOU in case such default or non-adherence is not rectified within such 30 days.
- b. Both parties also agree and undertake that despite any termination of the MOU, the progress of the ongoing course would continue without any hindrance and would be progressed for completion.

8. Entirety & Amendment:

This MOU contains the entire understanding between the Parties in relation to the course. If during the operation of the MOU, circumstances may rise which call for alteration / modification to this MOU, such alteration / modification shall be mutually discussed and agreed upon in writing. Such changes will be formalized



to this MOU not in conformance to this section shall be deemed to be void-ab-initio.

9. Confidential Information:

- a. Both parties undertake to each other to keep confidential all information (written or oral) concerning the business and affairs of the other, which has been obtained or received during the course(s) of performance hereunder, save that which is inconsequential or obvious;
- b. Already in its possession other than as a result of a breach of this clause; or in the hands of the public other than as a result of a breach of this clause.
- c. In the event of any of the parties becoming legally compelled to disclose any confidential information, such party shall give sufficient notice to the other party so as to enable the other party to seek a timely protective order or any other appropriate relief. If such an order or other relief cannot be obtained, the party being required to make such a disclosure shall make the disclosure of the Confidential Information only to the extent that is legally required of it and no further.

10. Other Terms & Conditions:

Following are the other terms and conditions of MOU:

- a. Batch Size: The batch size need to be a minimum of 08 students , as will be mutually decided by the parties
- b. Each student would be made available for the course for specified number of hours per day for the entire duration of the program.
- c. The students enrolled should complete the course as scheduled.
- d. Attendance will be the joint responsibility of SVIMS and PCA
- e. Duration of the course /courses will be decided every year with the mutual consent of both the parties.
- f. Fees collection will be the responsibility of PCA.

PROCESS:

We have HR Recruitment Partnership with them. At SKP there are vacancies for an "Accounts Executive" Position. We have a yearly target for their recruitments and so we have batch wise training for the candidates and the candidates will be trained for the SKP process itself. SKP is recruiting candidates from our batches. So every month we have to make a batch of 30 selected candidates as per SKP's given Criteria and Eligibility.

As they are fresher's we have a short process for selection. The Process includes following steps:

- 3 round of interview
- Successful Training
- Final Interview

During the First three rounds the candidate would be having face to face round and 1 Aptitude round. If the candidate qualifies these three rounds then the candidate will be provided a Skillful vocational training for about 30-40 days, where the candidate will be trained for SKP briefly.
